

Terms and Conditions

Christmas Promotion 2022

M4Markets, invites traders to participate in its "Christmas Promotion 2022" Promotion subject to the terms and conditions contained herein ("Terms and Conditions").

Promotion Period:

The Promotion is valid for <u>between Monday</u>, <u>December 5</u>, <u>2022 00:00 GMT+2 and Friday</u>, <u>December 31st</u>, <u>2022 23:59 GMT+2 only ("Promotion Period")</u>.

Eligibility:

 The Promotion is available to all clients (existing or new), excluding MAM/PAMM accounts, provided that they are eligible to participate to the Promotion which is subject to the M4Market's eligibility criteria as indicated in the <u>Client Services Agreement</u> and these Terms and Conditions.

Participation:

- 1. New clients should complete their registration process, verify and activate their Live trading account and make a minimum deposit of \$100 during the Promotion Period only.
- 2. Any existing client who wishes to participate to this Promotion should login to their client area and open a new Standard, Raw Spreads or Premium account and make a new deposit of a minimum of \$100 during the Promotion Period.

Terms and Conditions

- 1. The Promotion is available to verified clients trading on MT4/MT5 accounts.
- 2. The Promotion is limited to one-entry per client. Clients with more than one entry will be disqualified.
- 3. Existing clients who have not yet funded their accounts are eligible for this Promotion and should fund their accounts with \$100 during the Promotion Period to participate in the Promotion. Any available funds in existing or new clients' account which were deposited prior to the 5th of December 2022 will not be counted towards the minimum required amount to participate in the Promotion.
- 4. The Promotion is open only to individuals who are at least 18 years of age and have a solid understanding of FX and CFD trading.
- 5. In the event of any dispute misrepresentation of the above applicable Terms, such dispute or misinterpretation shall be resolved in good faith.



6. The Promotion is not available to EEA residents and certain other jurisdictions such as USA, Canada, Cuba, Sudan, Syria and North Korea etc.

Promotion details:

- 7. The promotion is divided into 4 sub-promotions.
- a. **Week 1** of the Promotion is between December 05th, and December 11th and it will offer clients the opportunity to earn cashback for every lot they trade on FX, Metals and Energies.
 - i. Clients will receive \$1 in cashback for every lot they trade.
 - ii. Cashbacks will be calculated at the end of the week and will be added to the Client's wallets.
- b. **Week 2** of the Promotion is between December 12th and December 18th and it will offer clients the opportunity to earn 100% Credit Bonus.
 - i. Each client can receive up to \$10,000 as credit bonus.
- c. Week 3 of the Promotion is between December 19th and December 25th and will offer clients the opportunity to upgrade to Raw Spreads or Premium Account with 50% off from the minimum deposit required to open the specific account chosen.
 Hence, clients can upgrade to Raw Spread account for 250USD only (from 500USD) and for
 - Premium Account from for 5,000USD only (10,000USD) during the specific timeframes specified in this section.
- d. **Week 4** of the Promotion is between December 26th and December 31st and it will offer clients the opportunity to join a raffle and win prizes from a total pool of \$5000.

ii. deny, withhold, or withdraw from the clients the Promotion and any profits generated from abusive trading behaviour or otherwise

- i. multiple registrations from the same IP address, multiple profiles, participation to the Promotion of third parties on behalf of the client without proper authorisation;
- ii. trading activities that can be counted as fraud, manipulation or attempts to garner risk free profits, trades entered or exited with latencies, opening and closing a trade under two (2) minutes.
- 2) If M4Markets suspects that a client has abused the rules of this Promotion and/or has been identified to have engaged in abusive trading behaviour in any way, M4Markets reserves the right at any time and at its sole discretion to immediately exclude the client from the Promotion and take additional actions depending on the abuse. This applies to cases where the client fails to meet certain requirements within the specified deadlines as requested by M4Markets related to the Promotion.
- 3) M4Markets shall not be liable for any consequences of the Promotion amendment, suspension or cancellation.

Miscellaneous
